1. License Grant

Crypto4A grants you a non-exclusive, non-transferable, nonsublicensable, limited license to use the Software solely as embedded in, installed on, or provided with the Hardware, and solely for your internal business or personal operations in accordance with any applicable documentation.

2. Ownership

Crypto4A retains all rights, title, and interest in and to the Software, including all associated intellectual property rights. Ownership of the Hardware is transferred to you upon purchase, subject to the embedded Software being licensed, not sold.

3. Restrictions

You agree not to:

- Modify, adapt, translate, or create derivative works of the Software.
- Reverse engineer, decompile, disassemble, or attempt to derive source code from the Software.
- Remove or obscure any proprietary notices or labels on the Hardware or Software.
- Use the Software separately from the Hardware or on unauthorized devices.
- Sell, lease, sublicense, distribute, or otherwise transfer the Software to third parties.
- Export, re-export, or transfer the Hardware or Software to any country or person prohibited by Canadian or other applicable export control laws.

4. Updates and Upgrades

Crypto4A may provide Software updates, patches, or upgrades at its discretion.

Updates may be subject to additional terms and conditions. Use of updates is governed by this Agreement unless otherwise specified.
